- 1. - 2. All Trust Unitholders should refer to the accompanying Information Circular for further information regarding completion and use of this Form of Proxy and other information pertaining to the Meeting.
- 3. To be valid, this Form of Proxy must be signed by you, as the Trust Unitholder, or by your attorney authorized in writing (including, if the Trust Unitholder is a corporation or entity, by a duly authorized representative thereof). Please sign this Form of Proxy in the exact manner as the name appears on the reverse side of this page. If this Form of Proxy is not dated, it will be deemed to bear the date on which it is received by Alliance Trust Company, the scrutineer for the Meeting.
- 4. If the Trust Units are registered in the name of an executor, administrator or trustee, this Form of Proxy must be signed in exactly the manner as the Trust Units are registered. If the Trust Units are registered in the name of a deceased Trust Unitholder, the Trust Unitholder's name must be printed in the space provided and the Form of Proxy must be signed by the authorized legal representative with his or her name printed below his or her signature.
- 5. If a Trust Unit is held by two or more persons, any one of them present or represented by proxy at the Meeting may, in the absence of the other(s), vote in respect of each Trust Unit so held, but if more than one of them is present or represented by proxy, they shall vote together in respect of each Trust Unit so held.
- 6. If you hold more than one class of Trust Units, you will receive one Form of Proxy for all classes of Trust Units that you hold. If you are voting your proxy using the internet, you will need to use the control number on the proxy to vote all of your Trust Units. The control number on the proxy will direct you to the correct website for voting OR you can follow the directions under "VOTE USING THE INTERNET" below.
- 7. The persons named in this Form of Proxy are representatives of the Administrator. A Trust Unitholder has the right to appoint a person other than the persons specified in this Form of Proxy (who need not be a Trust Unitholder), to attend and act on behalf of such Trust Unitholder at the Meeting. You may exercise this right by expressly striking out the names of the persons specified in this Form of Proxy and inserting the name of the person you wish to be appointed in the blank space so provided, clearly signing this Form of Proxy and returning it in the reply envelope or via the internet in compliance with the timing requirements described herein, or by submitting another appropriate proxy.
- 8. To allow sufficient time for your proxy to be delivered for use at the Meeting, you must complete, sign, date and return your proxy so that it is received by Alliance Trust Company, the scrutineer for the Meeting, no later than 5:00 p.m. (Toronto time) on June 8, 2026, or if the Meeting is postponed or adjourned, no later than forty-eight (48) hours (excluding Saturdays, Sundays and statutory holidays in the Province of Ontario) before the Meeting. The time limit for the deposit of proxies and other voting instructions may be waived or extended by the Administrator in its sole and absolute discretion.
- 9. Although you are strongly encouraged to vote by any of the means described in this document prior to the deadline set out in paragraph 8 above, arrangements have been made to allow for voting during the Meeting. Trust Unitholders may vote during the Meeting by following the internet voting instructions found below in the box labelled "VOTE USING THE INTERNET" by using the control number provided on this proxy.
